Report pursuant to Clause 125(1) of the Act No. 256/2004 Coll., the Czech Capital Markets Act, as amended (inside information), as well as pursuant to Article 17 of EU Regulation No 596/2014 on market abuse (Market Abuse Regulation)

Decrease of the share capital registered in the Commercial Register

Today, on 20 December 2018 the Commercial Register registered the decrease of the share capital of the company Kofola ČeskoSlovensko a.s. (hereinafter the “Company”), approved by the General Meeting held on 13 August 2018.

The registered capital was reduced by CZK 1,114,902,600, i.e. from CZK 2,229,500,000 to CZK 1,114,597,400. The reduction of the registered capital was made by cancelling 3,052 own shares of the Company with a total nominal value of CZK 305,200 and by reducing the nominal value of all the other shares of the Company from CZK 100 to CZK 50.

The Company's share capital, after the decrease made, amounts to CZK 1,114,597,400 and is distributed to 22,291,948 ordinary shares issued as book-entry shares with a nominal value of CZK 50 each.
