**Dividend for 2019**

Today, on 15 September 2020, the Board of Directors of Kofola ČeskoSlovensko a.s. ("the Company") decided to **recommend** to the General Meeting of the Company which will be held after the end of bank loan moratorium that it approve a **dividend for 2019** in the amount of **13.50 CZK per Company share, before tax**.

The expected date of the General Meeting is November 2020. The exact date of the General Meeting will be specified. The Board of Directors' recommendation is based on the current and expected development of the financial situation. If a significant negative change occurs in connection with the COVID-19 pandemic by the time of the General Meeting, the recommendation may be reconsidered.
